Thank you to the Salmon Arm Observer for its front page news report (January 24, 2018) concerning coal dust pollution from passing trains, and to Marijke Dake and her cohorts for bringing this to the attention of our local governments. However this is a serious issue warranting action by both the provincial and federal governments.

By law, companies such as coal exporters should not be allowed to transport goods without satisfactory protection for the public; in this case, physical covers, not just a surface spray which can be lost in transit, to prevent the spread of coal dust.

Contrary to common belief, we do not breathe in oxygen and breathe out carbon dioxide. We breathe in air including all its gases and airborne pollutants; and in the lungs, oxygen passes into the blood stream by linking on to haemoglobin, and in the lungs most of the pollutants will stay.

Although now accepted that smoking can cause lung cancer, it is not the lung's only carcinogen, nor is cancer its only medical problem. Any pollutant is a potential threat. There is much evidence that coal mining and other toxic industries such as steel production increase lung disease conditions. In my own life, an Australian nonsmoking aunt, living in Newcastle which for decades had the largest steel works in the southern hemisphere, contracted then died of lung cancer. I well remember when visiting as a child the grey smoky sky and how easily the window screens corroded. We were breathing in highly polluted air.

Also well known is that the "bottom line" dictates companies' policies and practices; and countries too grow wealthy based on this. But a country's greatest asset is a healthy population - with low medical costs an invaluable bonus. So steps must be taken by governments to protect its people, requiring businesses to implement safe practices whatever the cost.

Installing another spray station east of Salmon Arm is only a short term solution - and in fact if anywhere, it should be east of Revelstoke. More sensible and effective is physically covering the coal trucks with lids or tarpaulins, both of which are re-usable; while spraying with a chemical is not only not completely effective, but actually wasteful, using up a valuable resource material.

> I am writing regarding the condition of the side roads in Salmon Arm with the
snowy weather we have been experiencing this winter. It may have been extreme
over the weekend but it is not unique.
>
> I know the weather over the weekend was excessive but, nevertheless, I found
the response for road clearance to be poor, to say the least. I realize that the
City may not have the staff that it would normally have during the week, however,
Mr Niewenhuizen?s comments about the priority routes seems to be rather weak.
Surely the City has a responsibility for the safety of it?s Citizens, this,
despite any policies the City may have regarding overtime. Mother Nature does
not only work during office hours. With all the forecast information available
there is no reason for the City not to be on top of the conditions, certainly
considering the lateness of action with the first ?dump? we had before Xmas. I
have always been impressed with how the City has dealt with keeping the roads
clear for the 15 years that I have lived here but, for some reason, their
performance this season leaves a lot to be desired. Why is this? What has
changed? City policy? Speaking to body repair shops it appears that there have
been considerably more collisions because of the poor road conditions on Monday
and Tuesday this week than would normally be expected.

> As you know I live almost at the top of the first rise of 20th St. SE, up from
Okanagan. The degree of slope on that street is fairly severe leading onto
Okanagan and yet, despite being a main connector road to get downtown, there was
no effort to clear the road until the afternoon on both Saturday and Sunday. I am
amazed that there was not a major accident over the weekend. As far as the side
roads are concerned a large number still remain untouched, it now being Tuesday
afternoon. This is the area close to me but listening to other people complaining
it appears to be a general problem all around the City. This is not just my
complaint. I have heard it from numerous people about all areas of the city.
One big complaint was that the snowplough was depositing a barrier of snow and
ice right across the end of side roads joining the cleared road. Some of the
peoples cars could not exit into that main road. It?s one thing for this to
happen in front of your driveway but not at a road junction.

> Outside of our property we have the sidewalk which children use to walk to and
from school and it has only just been cleared. Also pathways between houses were
uncleared and when the snow plough cleared the adjoining roads the snow was piled

I am not sure if my question falls under your area of responsibility. If not, please pass is on.

I would like to know the process for the development of new subdivisions in Salmon Arm. I was under the impression that when new building sites came on-line that the City made the developer cover the cost of the new infrastructure needed. (Roads, sewer, water, power, sidewalks, street lights, etc.). I live in the Hillcrest area and as you know we have seen a lot of new building sites created. My question is in regards to the street lights installed in these new developments. Why are we still installing 40 year old technology in the form of HPS street lighting? This is what appears to have been installed in my area. The exception is the single lamppost installed on 20th Street South East just by Hillcrest School. In that instance you went with the new LED style lamp post. Would it not be prudent to install the best technology available when building these new developments? It seems sort sighted to install these old fixtures when in a few years we will be upgrading these newly installed lights to LED and saving 2/3rds the power the old units consume. Can you enlighten me as to why LED lights where not specified? Is there a plan in the future to upgrade all of the Salmon Arm street lights to LED? Is BC Hydro offering incentives/rebates for such upgrading programs? Looking forward to your response.

Hi Dave,

Thank you for your e-mail. It's always nice to see someone encouraging environmentally (and fiscally) responsible behaviors. I agree with your points below, but unfortunately staff are bound by regulations and not always common sense! The reason behind what you are seeing is that all works and services required through subdivision and development are regulated by the Subdivision and Development Servicing Bylaw. This bylaw dictates what works and services are required where and also what type of standard. The previous bylaw was written very stringently and did not give staff authority to make changes to the technical specifications. In 2016 we did a wholesale update to the bylaw which included changing the standard of street lighting to LED and verbiage to allow staff to make technical specification changes where it makes sense. In Hillcrest, the majority of the subdivision approvals happened prior to the new bylaw being in place, hence the HPS lighting. The later phases have been/will be approved under the new bylaw requiring LED lighting, so there will be a mixture up there.

The City has previously looked at a city-wide update to LED lighting, but at the time there was no mechanism by which to save money through the BC Hydro billing unless you were on metered billing which we generally are not; however, BC Hydro (reportedly) has changed their system to allow non-metered LED billing. As such the City has it on our 2018 project list to review options for a City wide update and assuming there is a good option for the taxpayers to present options to Council.

I hope this addresses your concerns, but should you have any questions or require further information please contact me.

We hereby request to commence site clearing works upon Development Permit approval to facilitate the proposed development of the Uptown Village at 1810 15th Ave NE in an accelerated manner.

Typically, site clearing does not start until a servicing agreement has been put in place. A servicing agreement is based on full engineering design approval, most specifically, an Erosion and Sediment Control Plan. Full detailed engineering design documentation including engineering reports, calculations, drawings and cost estimates will be provided to the City of Salmon Arm concurrently with the Development Permit application process.

To accelerate the challenging project schedule, targeting delivery of the first 7 units by fall 2018, we request permission to commence with the required site clearing while the details of the servicing agreement are being finalized as this typically occurs after Development Permit approval.

Prior to any site clearing commencing, the erosion and sediment controls would need to be constructed in accordance with a City Engineer approved Erosion and Sediment Control Plan.

Re: Invasive Mussel prevention in 2018

Dear Honourable Premier Horgan and Honourable Minister Heyman:

I am writing on behalf of the Shuswap Watershed Council to express our concern about the enduring threat that zebra and quagga mussels pose to the waterways in our region.

The Shuswap Watershed Council (SWC) is a collaborative partnership of the Columbia Shuswap Regional District, Thompson-Nicola Regional District, City of Salmon Arm, District of Sicamous, Secwepemc Nation, Regional District of North Okanagan, and the BC Ministries of Environment and Agriculture. Its mandate is to enhance water quality and safe recreation in the Shuswap watershed, including Shuswap and Little Shuswap Lake, Mara Lake, Mabel Lake, Adams Lake, and numerous rivers.

At a recent SWC meeting held in October 2017 in Salmon Arm, we were fortunate to hear directly from Ms. Martina Beck, Acting Aquatic Invasive Species Coordinator for the Province, about the Invasive Mussel Defence Program that the Province implemented in 2017. Thank you for your efforts to-date to prevent an introduction of zebra and quagga mussels; in particular, the improvements to the program in 2017 from previous years including a greater number of watercraft inspection stations, more staffing resources including a mussel-sniffing canine, and longer hours and seasons of watercraft inspection (including 24-hour inspection at Golden BC). These operations are much needed and appreciated. Ms. Beck reported that British Columbia remains mussel-free at this time – this is no doubt due, in part, to the Province's efforts as well as education and outreach efforts of many organizations, and the cooperation of travellers into BC.

However, the risk remains and the consequences of an accidental introduction of mussels are dire. In 2017, the Conservation Officer Service intercepted 24 mussel-fouled watercraft – it may sound like a low number, but it will only take a single boat, kayak, or paddleboard contaminated with mussels to start an irreversible infestation. Therefore, we are asking the Province to once again expand upon its Invasive Mussel Defence Program:

- Improve upon the existing watercraft inspection program
 - o Increase the number of stations to have one at every major entry point to BC
 - o Increase the stations' hours of operation and seasonal operation
 - o Add additional canine resources to the program
 - Improve the signage for mandatory inspection stations (to increase compliance of all types of watercraft, which have been at 80% for two years)

- Work with the federal Department of Fisheries and Oceans and Environment and Climate Change Canada to entreat other provinces to effectively contain mussel infestations
- Provide financial support for veliger (mussel larvae) sampling in the Shuswap watershed
- Expand upon education and outreach efforts to-date
 - o Maintain an up-to-date provincial website for zebra and quagga mussels
 - Provide financial support for large media and social media campaigns for the prevention of zebra and quagga mussel infestation in BC.

Prevention is key. If aquatic invasive mussels establish in one of our province's waterways, it will be irreversible and they will spread as they have been for 30 years in Canada. The ecological and economic impacts are conservatively estimated to cost \$43M annually to British Columbians – a cost we surely do not want to bear if we could have prevented it.

Thank you in advance for your ongoing efforts to keep BC waters mussel-free.

On behalf of Victoria City Council, I am writing to request the Provincial government take a leadership role in housing affordability, in partnership with the Federal government, First Nations governments, local governments, and housing providers. Specifically we request Provincial leadership in the following areas:

(1) Increasing the supply of non-market housing.

(2) Creating an inventory of public and private land suitable for development for affordable housing.

(3) Introducing effective fiscal and taxation tools to encourage the use of residential property to provide housing, and discourage speculation, "flipping," commodity investment and other market distortions that contribute toward a sharp escalation in the price of housing, including adjustments to the Property Transfer Tax to encourage residential occupancy and discourage speculation.

(4) Guaranteeing a dedicated and fixed portion of revenues from Property Transfer and Land Value Capture taxes for local Affordable Housing and Transit infrastructure.

(5) Extending Vacancy Taxation Authority to local governments, providing communities with the discretion to decide whether to introduce an additional tax to discourage vacant and derelict buildings, and encourage the occupancy, maintenance, and improvement of buildings to address housing affordability and public safety.

(6) Restoring the authority of local governments to introduce a Land Value Tax, to incentivize improvements to property for housing and other purposes, and create a disincentive to holding vacant property for speculative purposes.

(7) Consider granting local governments the authority to take title to vacant and derelict buildings, to encourage the occupancy, maintenance, and improvement of buildings to address housing affordability and public safety.

The picture above shows Austria's fleet of 18 state-of-the-art air ambulance / air rescue helicopters. This tiny country of 8.5 million has modern EMS but British Columbia doesn't, why is that?

Such modern EMS helicopter fleets are common in European countries and their use started over 63 years ago but not in BC; why is that?

The primary mission and justification of an air ambulance / air rescue helicopter, is to bring a multi-specialty doctor (combination Emergency Medicine Specialist / surgeon / anesthetist) to the critical care needs patient in the shortest possible time frame regardless of where they present. Hundreds of these air ambulance helicopters work all over the world every day, most are typically 'off the ground' and on-route to the patient within 2 minutes of the 911 call (as is the case in Alberta right next door). Their secondary role is to serve as the fastest possible transport means to the best possible treatment facility for the patient's condition or injury; now that is how modern EMS operates and BC has nothing even remotely close to that.

To be clear modern EMS / Rescue helicopters are but one component of a modern, highfunctioning, EMS model, other countries (and provinces) have long since been providing their residents with such modern additional lifesaving capabilities as: mobile (ambulance-mounted) CAT scanners, multi-specialty doctor-staffed 'fast' ground cars (which also carry universal donor whole blood to effective treat deadly bleeding injuries and restricted drug kits) and much more.

Europe today has over 260 such medical air rescue helicopters, all routinely land directly at the critical care needs patient's location, regardless of where they may be, and after (immediate) patient stabilization (by the helicopter doctor), the patient is transported directly to the best-suited hospital for their condition (at 250 kilometers per hour!) to such care facilities as Children's hospital, Level 1 Trauma centers / cardiac unit / burn unit / spinal / ICU units. The average German EMS helicopter will perform between 6 and 12 missions per days and the German EMS system has over 130 such EMS air rescue helicopters and have had starting in 1969.

Because the patient has already been triaged by the attending Emergency Medicine Helicopter doctor, they do require triage in the receiving hospital Emergency Room, hence, they are taken directly to a treatment ward / unit within the hospital where definitive treatment continues uninterrupted. This 'ER bypass protocol' alone saves precious lifesaving minutes for the patient and when seconds count, this protocol is an undisputed lifesaver - again, we have nothing like that in BC.

We suggest you take a moment to Google what a modern 'Trauma / Shock Room' looks and operates like in a typical Europe hospital, you will be amazed by what you will see - and then realize that BC has nothing even remotely close to such capabilities.

The above described level of emergency care is what the BC HEROS Society wants to bring to most if not geographic regions of BC, this, so that all British Columbians, regardless of where they live work or play, have at least a fighting chance of surviving a treatable but time sensitive condition, on what could otherwise turn out to be the worst day of their life.

BC does not have a best-possible-patient-outcome EMS model, but rather, BC has a 'perceived', lowest-cost-per-patient-transported EMS model and there is a 'life-and-death' difference between the two models.

Here is a fact that completely baffles us; our politicians live in the same communities we do, so why don't they want a higher level of EMS critical care for their loved ones, for their children and grandchildren? Don't they realize that at some point in their life they too may need a urgent ambulance ride, so why don't they create such a system while they are able to so? Is it shortsightedness or just plain 'it-will-never-happen-to-me-or-anyone-I-love' arrogance; we suppose time will tell but dear politician, remember this fact: 585,000 people get an ambulance ride each year in BC, that is 12.5% of BC's population; in lottery tickets odds, those are great odds; do you really believe nothing will never happen to you or someone you love? If you do, perhaps check with some of your colleagues, current and former, and see if they or any of their loved have never needed an ambulance ride.

As you read on, you will come to see just how dysfunctional BC's chosen EMS model is and has been for over 4 decades, and to be clear, the fault lays squarely with past and present provincial governments, including past premiers and health ministers; all of whom knew of the extreme systemic dysfunctions of our chosen ambulance service model – and chose to do nothing.

When a person finds themselves in a life-threatening medical situation at work, at home or at play in BC, do you think they care what uniform the person responding to their emergency call is wearing? Of course they don't ! Well know this; 43 years ago, the 1974 NDP government legislated a bizarre EMS service restriction / law which restricts all higher levels of prehospital treatment (and patient transport to a hospital), to only one small subset of BC's 24,000 front-line first responders; namely, to only the 3,750 ambulance attendants members of the BC Emergency Health Service (formerly called the BC Ambulance Service). This care and transport provision restriction remains in place today and even prevents multi-specialty emergency medicine qualified doctors and nurse practitioners from working in the prehospital EMS setting; why is that? How does such an highly restrictive critical EMS care provision model ensure a best possible patient outcome for our loved ones?

Why on earth would any caring MLA vote for such a bizarre life-threatening law? Is it not common sense that **ALL** appropriately medically qualified and licensed first responders be allowed to assist any person in medical distress and to the full extent of their medical licence and training, regardless of what uniform they wear or union they belong to?

So why does the BC Ministry of Health / BC Emergency Health Service Commission still continue to enforce this deadly and bizarre 43-year-old EMS service provision restriction? Why does the Minister of Health, Mr Adrian Dix, allow this deadly insanity to carry on; he has it within his authority to rescind this restrictive clause today, simply by signing the appropriate paperwork !

To underscore just how bizarre this restricted EMS service provision approach is; if a patient has fallen ill or collapsed in a hospital parking lot, it prevents that patient from being moved into the emergency room by any first responder professional - other than a BCEHS ambulance attendant. All other professional first responders, as well as ALL other in-hospital medical professionals, are **NOT ALLOWED**, to move or treat such a patient, yet a Good Samaritan bystander can! And it has been that way in BC since 1974. Now imagine being that patient, worse, imagine that happening to your loved one, seeing doctors, nurses, firefighters, police officers, search and rescue personnel all standing around your loved one, waiting for an ambulance attendant to move your loved one the few meters into the hospital to save their life. For four decades, that has been the law in BC.

Now understand this: some international EMS jurisdictions actually have federal laws which make **medical professionals subject to prosecution if they DO NOT assist all persons in medical distress**, regardless of where they present. Doesn't that make sense?

Given all the obvious inherent shortcomings and dysfunctions of our byzantine chosen EMS service provision model, how can anyone state that it ensures a best-possible-patient-outcome for our loved ones? Well of course it doesn't. BC is the only province in Canada which still has such restrictive EMS care provision for prehospital patients; the question is why and whom does such a highly restrictive EMS care provision model best serve, the critical care needs patient, or the members of BCEHS, who are the sole legal service providers? Looks pretty obvious to us and this needs to change.

The BC Emergency Health Services Act was created in 1974 by the Dave Barrett NDP government, while the act has been updated on a number of occasions since, the sole first responder EMS service provision restrictions continue to be the law in BC and still excludes the vast majority of first responders and medical professionals, and many of our loved ones have and continue to paid a heavy price. This crazy and deadly law **MUST BE RESCINDED** before thousands more of our loved ones die or sustain permanent injury from completely treatable but time-sensitive conditions, due in whole or in part. to this incomprehensible care provision restriction.

British Columbia needs thousands more ALS paramedics

Our province has 630,000 more residents than Alberta, has one-third more land area than Alberta, a 27,000-kilometre coastline and far more challenging topography. Yet **Alberta has 5,577 MORE** Emergency Medical Technicians (known in BC as Emergency Medical Attendants) than BC. All of Alberta's 9,327 EMTs, are legally allowed to treat and transport sick and injured patients from the prehospital setting to a hospital emergency room. Alberta also allows and employs, doctors and nurses to be first responders.

In comparison, BC only has a total of 6,786 registered EMAs/ EMTs but only 3,750 are legally allowed to treat and transport 'general public' patients to a hospital. The remaining 3,036 may only treat patients if they are on private property or at a company facility.

Due to Alberta's use of a different EMT training and hiring model, our neighbours to the east have 2,668 Advanced Life Support paramedics (who have 1,770 hours of training). In Alberta, the ratio of ALS paramedics to population is 1 for every 1,500 residents. BC has just 240 ALS paramedics available for general public treatment and transport, that works out to 1 ALS paramedic for every 20,000 residents! To be sure BC's ALS paramedics are highly capable medical professional in the prehospital setting as they are allowed to administer restricted drugs and carry out minor medical procedures but they are not as capable as a multi-specialty doctor which have many more years of medical training.

To make things even worse for rural BC residents and workers, not one of BC's ALS paramedics are based outside our larger centers. For the province's nearly 1.5 million residents who live, work and play in rural BC, this leaves them dangerously unprotected and highly vulnerable to

death or permanent injury from easily treatable but time-sensitive conditions which Basic Life Support attendants are not trained or licensed to treat. Looking at a map of BC, it's easy to see that vast areas of British Columbia are without ALS paramedic coverage.

FACT: This - chosen - lack of ALS coverage for rural BC, has directly or indirectly, contributed to the treatable deaths and permanent injuries of many hundreds, if not thousands of time-sensitive condition patients over the last four decades.

As if that isn't enough, BC does not even have one doctor working as a first responder anywhere in the province, not even in Vancouver's West End which has one of the high population densities in the world.

FACT: Extensive prehospital use of doctors has been commonplace in other jurisdictions since the mid 1950s. But not in BC.

The 1974 BC NDP government did away with that and made the use of doctors, as first responders illegal. Why would any caring MLA vote for that, especially considering many of them live in rural BC themselves - as do their own loved ones!

FACT: All subsequent Social Credit, NDP and Liberal government MLAs also chose NOT to change this bizarre EMS provision restriction. All were fully aware such restrictions would contribute to preventable permanent injury and death to their constituents. No MLA - or government - since 1974 is without blame or guilt (except perhaps the Greens – at least so far).

FACT: BCEHS has some of slowest ambulance response times of any modern western society.

BCEHS comes nowhere near the North American benchmark standard for ambulance response times of 8 minutes 59 seconds for 90 per cent of their calls (the European set standard is 7 minutes 59 seconds, 90 per cent of the time). In fact, BCEHS doesn't even report in 90th percentile response times, they report in 50th percentile. This a feeble and clearly misleading attempt to make their ultra-slow ambulance response times look better to the uninformed observer, that would be you, a member of the general public.

FACT: Every single ambulance in Calgary is an ALS ambulance, not even Vancouver or Victoria have that level of ALS coverage.

Unless you are one of the lucky patients who live within areas covered by BC's few ALS paramedic ambulances, you will get a Basic Life Support crew.

FACT: Roughly 94 per cent of BC's ambulance attendants are only Basic Life Support qualified, which means they only have 680 hours of training. Of BCEHS's 2,850 BLS attendants, 63 per cent (1,787) are part-timers. If you live in the more remote parts of BC, you will most likely get an Emergency Medical Responder (EMR)-qualified crew. They only have 107 hours of total training. Most Basic Life Support attendants are only allowed to give patients over-the-counter medications and are NOT allowed to administer (restricted) lifesaving drugs or perform even minor surgical procedures. This restriction is NOT the fault of rank and file ambulance attendants, it is squarely the fault of their employer, the BCEHS and the Ministry of Health; they are the ones that have chosen this inferior level of EMS coverage for us all - without our knowledge or informed consent.

The takeaway message is clear: BC desperately needs at least 2,000 more full-time ambulance attendants - all of whom MUST be ALS-qualified. We need at least 200 more ambulances, at least 50 more ambulance stations, and at least 50 multi-specialty doctors providing EMS treatment in the prehospital setting to treat our most critically ill and injured loved ones.

In addition to the above, and as a major demand of this petition, BC HEROS wants all currently working BCEHS BLS attendants to be up-trained to ALS licence level - with full pay - as soon as possible.

At the same time, we also demand that the BC government amend all regulations which continue to restrict ALL other first responders from being able to provide full-spectrum EMS care - if so licensed and trained - regardless of what union they may or may not belong to or what uniform they may wear. That is the only way to move BC to a best-possible-patient-outcome EMS system.

There is no question that our demands for change will not only save far more lives each year in BC but will also save BC society billions more in annual health care costs. That is the real reason why other countries (and provinces) invested heavily in modern state-of-the-art prehospital emergency care decades ago; because it saves far more money than it costs! The sooner a critical-care-needs patients receives definitive care, the higher the chances of survival, the lessor the chances of permanent injury, the lower the cost to society and taxpayers.

Mountains, islands and long distances are no barrier for world-class EMS

BC is not the only region in the world which has to contend with vast distances, mountain ranges, islands, remote villages and extreme winter weather, yet other EMS jurisdictions handle all these conditions in stride.

To further complicate our chosen low-functioning EMS delivery model; all our highest care level facilities are located at the southwest-most corner of the province. That makes no sense considering BC has a land area the size of the 39th largest country on Earth - or the size of France and Germany combined.

Countries like Norway, with a population of 5.2 million, face similar EMS service provision challenges, yet they realized decades ago that the best way to provide their residents with state-of-the-art EMS care, is to use a coordinated system of 26 dedicated EMS helicopters and medevac aircraft. They have the ability to fly paramedics and doctors directly to the patient for decades – regardless of where they are located in their very long country.

When our loved ones fall ill or injured, wherever they might be in our province, they deserve an emergency medical system they can count on, one that will respond in a timely fashion in their time of need with the most medically-capable personnel possible. They deserve the same level of care that other countries have been providing their residents for many decades. Unfortunately, the average British Columbian still believes BC actually has such a world-class EMS system, and this only because they continue to be misled by senior managers at BCEHS and other government officials.

BC's still relies on what is referred to in the EMS world as the 'Scoop and Run' model of ambulance service provision.

The Scoop and Run EMS model relies on an low medical ability ambulance crew rushing to the critical-care needs patient as fast as they can, then rushing the patient to a doctor in a nearby hospital as fast as they can. Only once the patient is in the hospital, does the patient stabilization process / definitive medical treatment start. In a modern, high functioning 'Stabilize and Transport' EMS model, the patient stabilization and definitive treatment process starts much sooner as this EMS approach **essentially 'brings the hospital to the patient' as the** multispecialty doctor is rushed to the critical-care needs patient. The net effect is obvious - much sooner stabilization results in better chances of survival and fewer, less-severe permanent injuries.

To be clear, the Scoop and Run EMS model is an outdated EMS model and does NOT employ long-known and proven EMS best practices.

FACT: When a low-functioning Scoop and Run EMS model is combined with very slow ambulance response times (due to our extreme attendant and ambulance shortages all over BC), it can easily become a deadly combination for patients with treatable but timesensitive conditions, such as heart attack, stroke, bleeding, airway/breathing issues, and anaphylaxis.

GRIM FACT: We estimate between one and three people die each day in BC from completely treatable conditions, due in whole or in part to the chosen EMS model we still use today in BC. This estimate does not include the many opioid overdoes victims; when these victims are added into the overall numbers of 'treatable deaths' each day, the toll could be higher.

Fiduciary Obligation of the BC Government

In 1974, when the BC NDP government chose to legally restrict all aspects of EMS care provision (to the general public) to just one smaller subset of our total first responder group - then the government was left with a fiduciary obligation to provide the people of BC with a state-of-the-art, modern EMS model. Well they still don't do that 43 years later.

FACT: no voter, in any BC community, has the ability to vote for a mayor and council that will promise more/better EMS resources for their residents. This HUMAN RIGHT was

taken away from all our civic politicians (and voters) in BC in 1974 when the NDP created the EHS Act.

Yet civic voters in our communities can still vote for civic politicians who will give them more police and fire rescue resources - but not EMS resources.

FACT: The most salvageable patients of the entire health system, present as time-sensitive condition patients in the prehospital setting. They are the easiest and lowest cost to save, yet BCEHS employs a very limited-ability, critical-care patient needs EMS model. When combined with very slow ambulance response times, people die, salvageable patients die, our loved ones die, simple as that.

The solution costs only five-cent per person per day

Would you pay just five cents a day to have a modern, world-class EMS system throughout BC? Every person we've asked emphatically stated YES! That is all it would take to bring worldclass, 21st century EMS to all areas of BC. For just five cents per person per day, BC would be able to fund all the necessary changes, upgrades and training needed. Five cents is the refund of an empty pop bottle. Is that too high a price to pay to save hundreds more of our loved ones lives every year?

The cost of Government inaction to taxpayers/BC society as a whole is staggering

According to BC Trauma (a branch of BCEHS) and the Fraser Health Authority, the cost of trauma alone (not including all other time-sensitive conditions) to B.C. society is between \$2.8 and \$5 billion per year. Despite that staggering annual cost, to the best of our knowledge, the BC Ministry of Health has never carried out a (non-partisan) universal cost-benefit analysis to definitively determine if the EMS service levels provided by the current model used in BC is actually cost effective. Such universal cost-benefit studies have been mandatory under federal law in some European countries for more than 40 years. In private business, such cost benefit analysis help companies determine which business units within their firms are profitable and which aren't. They are mandatory for Fortune 500 companies but not at BCEHS; why is that?

Furthermore, and completely unbelievable, BCEHS does NOT track patient outcomes after they drop patients off at the hospital emergency room. They have no idea how the patient responded through the chain of care and rehabilitation. There is no way they can definitively assess whether the levels of care they provide or the response times they provide, saves more lives or reduces more permanent injuries.

Clearly, such gross incompetence leads all the way up to highest levels of government starting with all senior management at BCEHS, PHSA and the Ministry of Health. Even the current health minister should be held accountable, as we have made all this information available to him long before we started this petition. **They all knew and chose to do nothing!**

Point of fact; there is not one thing that the BCEHS EMS model does that is world leading, not one thing. Get this, many BCEHS ambulances don't even have actual winter tires, not one has

automatic tire chains (like every single fire truck in BC), this while other EMS jurisdictions have long since enjoyed the lifesaving benefits of mobile CT scanners, multi-specialty surgeon/anesthetist /emergency medicine doctors on rapid-response helicopters (off the ground in less than two minutes) and rapid-response ground cars, universal donor whole blood, lifesaving drugs and more. We in BC still have none of these capabilities, not even in downtown Vancouver. Yet all at BCEHS, including past and present health ministers, keep insisting we in BC have had a world-class EMS system for decades. Think about that the next time your loved one desperately needs an ambulance ride. Who are you going to hold responsible if the outcome is not great? Not the rank and file ambulance attendants, they are doing the very best they can with the limited resources our government provides them to work with. Blame your local MLA, blame the incompetent managers at the Ministry of Health, BCEHS, PHSA; they all knew of the problems and the solutions and chose to do nothing. Hold them accountable, when you are told: "Everything possible was done to save your loved one." They are lying to you. What they should be telling you is: "We did all our low-functioning, highly-dysfunctional EMS system allowed us to do, which is nowhere near what we could have been doing to save your loved one."

Also remember this fact; your ICBC rates are affected by increasing medical costs, so are your WorkSafe BC premium rates and so on. So if you think the BCEHS low-functioning EMS model doesn't affect you, guess again, it costs us all far more than we realize. It affects every single resident in the province, both from a potential patient point of view, as well as from a taxpayer point of view. So if you own a car, a business, or are an employee, think about what portion of your income is wasted on thousands of patients in long-term care facilities today. Perhaps they didn't need to be there but the emergency system worked against them Think about the massive ICBC insurance payouts that are made due to slow ambulance response times and so on. Then think about the pay raise you didn't get, because your employer has to pay through the nose for Worksafe BC premiums.

Based on what other First World nations have found over the past 40 years, the only way to know for sure what amount is sufficient to spend on enhanced prehospital care is by carrying out universal cost benefit studies every four years. Only this way can a socialized society like BC/Canada, truly determine if we as a society, are spending enough money on our prehospital care system. We are certain that a dramatic enhancement of BC's EMS model would provide all British Columbians with not only much sooner ambulance response times and better patient outcomes at a lower cost, but will also provide much sooner patient pain relief for primary care patients – another definitive marker of a modern EMS model.

By signing our petition we will be able to show our politicians that British Columbians are no longer willing to accept lies and deception from all government stakeholders. We want the same level of EMS care that other jurisdictions have benefited from for decades. We demand modern EMS now.

Hospitals are full of people that were sure it would never happen to them. No one ever thinks it will ever happen to them, until it does. No one thinks they will slip in the shower or get T-boned in an intersection on the way to work or school, until it does. But when it does, you or your loved ones will at the mercy of BC's inadequate, highly dysfunctional ambulance services model.

Please understand this simple fact; if you chose not to speak out now, our politicians will NOT ACT. Now that you know the facts, please hold your MLA accountable. Only by working together can we make a difference!

RE: <u>Revenue from Cannabis Sales – Equitable Share between Province and Local</u> <u>Governments</u>

As the decriminalization of cannabis by the Federal Government is fast approaching, Local Governments in British Columbia have been discussing and developing draft regulations that will dictate land use, business operations and enforcement activities necessary to properly manage the sale and use of cannabis in our communities.

We understand the arrangement has been set by the Federal Government to share 75% of the sales revenue with the Provinces and Territories. We fully understand that the Province of BC will have significant costs associated with the creation and implementation of distribution processes and procedures for both wholesale and retail sales.

Local Governments in BC will also have significant costs in the creation and administration of various bylaws, policies, and procedures to ensure the safe and appropriate siting of sales outlets, the administration of sales and usage as well as the ultimate enforcement of these activities.

We respectfully request that you as Minister of Public Safety and Solicitor General urge your colleagues in Cabinet to consider sharing the revenues received from the Federal government equally between the Province and the Local Governments as a 50/50 split. We support other communities' requests for the same revenue sharing formula, and are of the opinion that this is equitable and appropriate to cover the costs associated with the responsibilities of each level of government in BC.
