Dear Mayor and Council,

The Shuswap Community Foundation's Grants-in-Aid Adjudication Committee met on January 5th to review the applications for funding received for the City of Salmon Arm Grants-In-Aid Program.

The Committee is comprised of Mayor Alan Harrison and Shuswap Community Foundation Board members: Ralph Segreto, Lindsay Wong, Kathryn Vennard and Manager, Roger Parenteau.

With \$54,625 available and requests totalling \$98,906, the Committee faced difficult decisions. We are pleased to announce that 15 groups were approved and will receive funds in March. A spreadsheet with a list of the allocations is attached.

Following the adjudication, \$11,613 remained unallocated. The adjudication committee is seeking councils' permission to hold a second intake of applications with a deadline of May 15, 2022.
