Schedule 'B'

Solid Waste Not Eligible for Refuse Disposal (Prohibited Materials)

(In accordance with Bylaw 4281 – Curbside Collection of Refuse, Recycling, Food Waste & Yard Waste)

Prohibited materials include but are not limited to the following:

- Agricultural waste;
- Animal excrement not contained in a sealed bag;
- Antifreeze and antifreeze containers;
- Appliances (gas and electric);
- Asphalt shingles;
- Automobile bodies and parts;
- Barrels or drums in excess of 205 1itres (45 gallons), whether full or empty;
- Batteries (including lead-acid batteries and rechargeable batteries);
- Biomedical waste;
- Child/infant car seats;
- Concrete and bricks;
- Controlled Waste;
- Dead animals;
- Demolition, land clearing and construction (DLC) waste;
- Drywall and gypsum board;
- Electronics and electrical products;
- Exercise and mobility equipment (e.g. bicycles, treadmills electrically or manually powered)
- Household Hazardous Waste (HHW) and Hazardous and Special Products (HSP);
- Biomedical waste;
- Inert fill materials including soil, sod, gravel, concrete and asphalt;
- Light fixtures, light strings and light bulbs;
- Liquids and semi-solid wastes and sludge;
- Log yard waste;
- Mattresses;
- Medical sharps and medications;
- Metal waste;
- Noxious matter;
- Oil, oil containers and oil filters;
- Outdoor power equipment (gas and electric);
- Paint products and paint containers;
- Pesticide products;
- Pharmaceuticals;
- Polychlorinated Biphenyls (PCBs);
- Porcelain (e.g. toilets, sinks);
- Pressurized tanks and canisters (e.g. propane tanks, butane canisters);



- Radioactive and reactive waste;
- Refuse that is flammable, explosive on fire or smoldering;
- Refuse that would cause undue risk of injury or occupational disease to any person or that would otherwise contravene the Occupational Health and Safety Regulations;
- Septage;
- Smoke and carbon monoxide (CO) alarms;
- Solvents and flammable liquids;
- Thermostats (mechanical, digital and mercury-containing);
- Tires;
- Wood waste;
- Any single object weighing more than ten (10) kilograms or measuring more than one (1) metre in size in any direction; and
- Materials accepted through one of the following curbside collection streams (*refer to Schedule A List of Accepted Materials*);
 - Food waste
 - Recyclables
 - Yard waste

The City utilizes the Recycle Coach app which provides detailed "what-goes-where" recycling and disposal information for any type of material or item, along with other useful functionality related to the curbside collection program, such as address-specific collection schedules and City notifications.
