Mosquito Control Program

Dr. A. Borkent presented to Council regarding mosquito biology and mosquito control methods. His presentation detailed the lifecycle and dispersal range of mosquitoes, concerns around using biological controls like Bti (Bacillus thuringiensis israelensis), and the broader ecological risks. Dr. Borkent emphasized education over chemical or bacterial control programs.

2024 Local Government Climate Action Program Survey

Council endorsed the City's submission to the Provincial Local Government Climate Action Program. The 2024 report noted city-wide emissions at their second-lowest recorded level (1,343.4 tonnes CO_2), primarily due to curbside organic waste diversion and ongoing LED lighting upgrades.
