### Douglas-fir Beetle Salvage in East Canoe Creek Community Watershed

Ray Mills of Canoe Forest Products presented an overview of the proposed douglas-fir beetle salvage harvesting project in the East Canoe Creek Watershed, which supplies a portion of Salmon Arm's drinking water. The project aims to reduce wildfire risk and beetle spread by removing dead and dying trees over the winter months.
